What is the Erasmus+ Project?

Erasmus+ is a project where the beneficiaries are 36 individuals from the EU and 9 from the UK. These are youngsters aged between 16 and 22. The successful applicants will be those who are striving towards entrepreneurship whilst having the objective to develop entrepreneurial values, attitudes as well as policy making.

What does the Erasmus+ project offer to its beneficiaries?

The project offers learning opportunities in developing practical entrepreneurship skills. There are a total of 4 trips each lasting 1 week each at Spain (Jul 2017), Romania (Jan 2018), UK (May 2018), Portugal (Nov 2018).

There are two main objectives of the project, the first is to teach business fundamentals by providing the knowledge and skills necessary for the youth to start their own business. The second objective is to enhance the youths business skills for future opportunities through hands on experience.

COSTS COVERED BY THE PROJECT:

- 1 week for each country to focus on development of entrepreneurial values, attitudes as well as policy making. Learning business skills and enhancing those skills through practise
- Return flight tickets to and from the project destinations (coverage costing for return Terravision Bus Tickets , travelling to airports in London)
- Insurance Coverage during all your stay including medical expenses and third party liability
- Meet & Greet on arrival at Spain, Portugal and Romania Airports
- Private transfers from the airport to accommodation on arrival and departure
- 'Welcome Meeting' during the first day, to discuss placements and the programme with the hosting partners
